SUMMARY

The incumbent is responsible to keep the plant operating; to make minor adjustments and repairs; to contact key personnel when serious problems arise.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

1. To keep Plant, Operations Building, Laboratory and Process Buildings clean; mow grass and weed eat.
2. To collect influent and industrial samples; see that they are stored correctly and paperwork is complete.
3. To take chlorine tank weight readings.
4. To check oil level in blowers and fill when needed.
5. To check all equipment at Plant and Pumping Station's.
6. To turn on sampler and collect samples for bio-monitoring; see that paperwork is completed for Pretreatment Coordinator.
7. Have certain laboratory equipment ready for Laboratory Supervisor when needed.
8. To clean influent and industrial jugs.
9. Record total influent flow and total effluent flows (daily).
10. Calibrate Lab equipment, when requested.
11. Check drying oven and incubator.
12. Check Sawmill and Eagle Mountain pumps when power goes out.
13. Perform other related duties as required or assigned.

EDUCATION AND EXPERIENCE

High school diploma or GED.

LANGUAGE SKILLS

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to speak effectively before groups of customers or employees of organization.

Ability to utilize both internal and external resources to obtain information and data necessary to carry out routine assignments and special projects. Must have ability to establish and maintain effective working relationships with management and staff.

PHYSICAL DEMANDS

The employee must regularly lift and/or move up to 50 pounds. While performing the functions of this job, the employee is occasionally exposed to wet/and or humid conditions; moving mechanical parts; high, precarious places; fumes or airborne particles; toxic or caustic chemicals; outdoor weather conditions; risk of electrical shock; wastewater biohazards.

The noise level in the work environment is usually moderate, but occasionally loud for short periods of time.
