**Water** portion of bill is calculated based on water usage. The meter is read in terms of hundreds of gallons. Meters are read starting the first working day of the month. The date of your meter reading is noted on your bill as the service end date of the service period.

Residential Sewer Rates are based on 4 mo. Dec-Mar winter avg. Otherwise billed 1 to 1

Residential **Sewer** bills are determined by average wintertime (Dec, Jan, Feb & March) water consumption. If there is no wintertime average, sewer usage is determined by the **actual** water usage.

**Payment of Water Bill(s) Options**

1. By Cash, Check, or Debit/Credit Cards. (ph in charge: \$3.00)
2. Auto Bank Draft (on or around the 10<sup>th</sup> of each month no/chg)
3. On Line internet pay cityofbatesville.com\utilities-charge: \$2.00
4. Bank Pay (can take up to 14 days)

**Payment of Water Bill(s) locations:**

1. Inside Window (City Hall-1<sup>st</sup> floor)
2. Drive-Up Window (behind building)
3. Night Depository (beyond Drive-up Window)
4. Use Night Deposit drop if receipt un-needed

**Payments must be In our office by the 20<sup>th</sup> to avoid the past due penalty.**

**BILLS** are mailed to customers on the **last** working day of the month. If you do not receive your bill by the **5<sup>th</sup>** of the month, please call the Water office (870-698-2415) & inquire about your account. **First** bill can take 2 months to bill.

A **DEPOSIT** appropriate for the area of connection shall be paid **before** service is connected. When a customer moves, the deposit is either transferred to the new residence **OR** applied to the final bill when service is disconnected. After a deposit is applied to a final bill, any refund will be mailed to the customer at the forwarding address given at time of disconnection.

**IF IT IS NECESSARY TO DISCONNECT SERVICE, CHARGES DUE WILL BE: PAST DUE BILL PLUS A \$40.00 DISCONNECT/RECONNECT FEE. THIS MUST BE PAID BEFORE SERVICE WILL BE RESTORED.**

**AFTER 5 p.m. CONNECTS/RECONNECTS: \$70.00 OVERTIME CHARGES WILL BE ASSESSED.**

**BATESVILLE WATER UTILITIES WATER SERVICE LINE  
REGULATIONS AND SPECIFICATIONS IN COMPLIANCE  
WITH THE ARKANSAS STATE PLUMBING CODE**

**NOTE: If a Batesville wastewater system connection is not available to you, you must present to Batesville Water Utilities a septic system certificate from the Independence County Health Office prior to any new water meter installation.**

**Place the blue flag where you want the meter installed on your property at the main water line. The water meter will be read monthly and must remain easily accessible to the meter reader.**

**Minimum line specifications: ¾ inch schedule 40 (larger line may be required for some applications).**

**Minimum depth from the top of the ground to the top of the pipe: 18 inches.**

**Minimum Bedding: 2 inch layer of sand or rock free soil under the line.**

**Minimum Backfill: 4 inches of sand or rock free soil on top of the line. If the base soil is rocky, a minimum of 12 inches of clean earth containing no stones, boulders, or cinder fill is required.**

**A Batesville Water Utilities inspector must inspect the service line before it is covered. Upon installation, the meter will be locked off. The BWU inspector will unlock the meter when the service line is approved.**

**Stand alone frost free hydrants must meet code and be equipped with a RPZA back flow prevention device before water service can be approved.**

**A cut off valve must be installed in the service line within one (1) to three (3) feet from the meter. Where water pressure within a building exceeds 80 psi static, a pressure regulator shall be installed in the service line between the cut off valve and the structure. If a pressure regulator or backflow prevention device is required, a thermal expansion tank shall also be installed.**

**A minimum 12 inch air gap (disconnection) must exist between a well and the public water system or service line. The well line must be capped and can not be connected to any system that is connected to the public system unless a reduced pressure zone assembly (RPZA) is installed after the meter and before the well connection. A certified tester must perform a physical test on all backflow prevention devices annually.**
